## MATCH PROGRAM (REDUCED LEGAL FEE)

The Match Program is a reduced fee program that assists modest income legal consumers to obtain legal counsel. The maximum hourly rate for eligible clients is \$75.00 per hour. As an incentive to participate in the Match Program, percentage fees to LRS are waived.

If you handle only Match Program referrals, LRS will waive first year dues and will provide malpractice insurance coverage. If you handle full fee LRS referrals, you are required to have professional liability insurance coverage at your expense.

LRS staff initially screens Match callers using the federal poverty guidelines. Callers are informed of the hourly rate and given information that a retainer may be required. *The attorney is strongly encouraged to further screen the client*. If you find the client does not qualify for the Match program (income is not within accepted guidelines), you are required to notify LRS.
